Throughout the year, the Livingston County Community Alliance, in conjunction with the Michigan State Police, perform 100+ alcohol compliance checks throughout Livingston County. When performing compliance checks, an undercover Michigan State Police Trooper, along with a minor, visit randomly selected alcohol retailers in which the minor attempts to purchase alcohol. These "stings" ensure that employees are complying with Michigan liquor laws and not selling alcohol to anyone under the age of 21. The Livingston County Community Alliance would like to recognize the retailers that did not sell to minors.

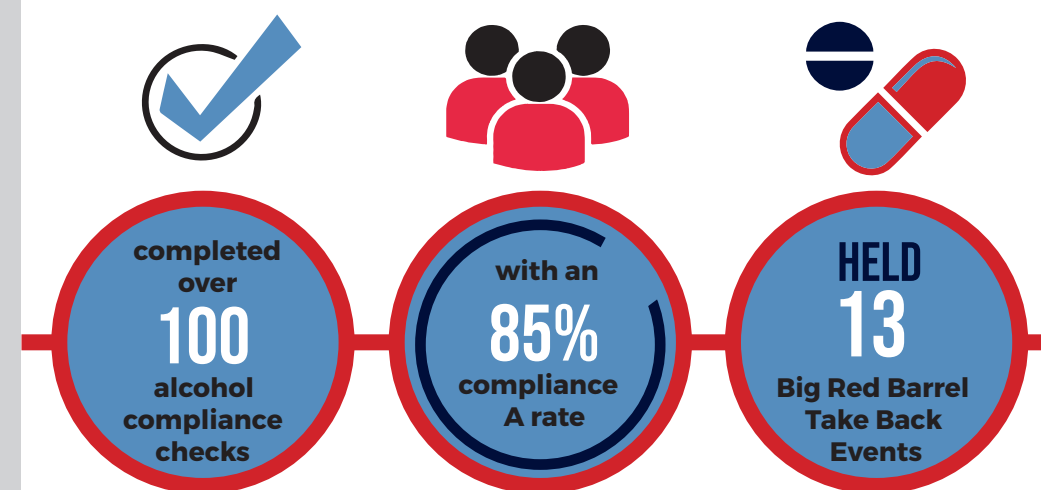

PARTNERED WITH WAKE UP LIVINGSTON

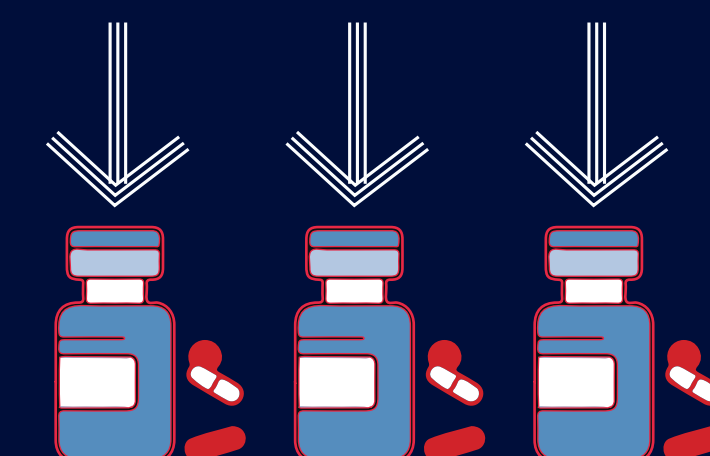
to complete Reality Tours in the county with over 50 participants, an experiential activity for youth and parents to help them dialogue about drugs and alcohol and their expectations.

CELEBRATED THE COLLECTION OF OVER 194 POUNDS OF UNUSED MEDICATION

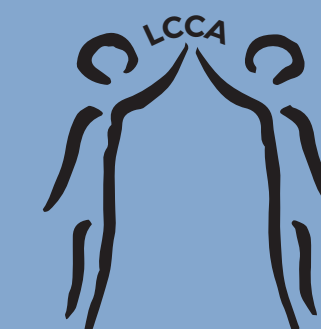
